

VILLAGE PRESIDENT'S MESSAGE

There is a lot happening in our village.

The new Christmas decorations will be up in early December. Thank you to those who have already donated. If you pledged funds and have not paid, please drop off your donation in the payment box at village hall. We are still in need of donations. If you would like to help, make checks payable to Village of Cleveland and please note that it is a donation to the Christmas decoration fund.

The pedestrian bridge at Hika Park has been installed. The former dam impoundment has taken many grant cycles to restore, and the bridge is the latest phase. The village is fortunate to work with Lakeshore Natural Resource Partnership for planning and grant assistance to make these safety and aesthetic improvements a reality. Please enjoy the park on the North side of the creek but keep in mind that public parking is on the South side of the creek and there is no parking in the public works garage parking lot. Also, be mindful that there is no public access to the public works garage area and residents' private property to the North and South of the park. There is ample area to enjoy the beautiful lakefront within the park boundaries.

The water utility recently applied for a water rate increase with the Public Service Commission (PSC). The PSC takes many factors into account in setting the water rates for the village. The last rate case was completed in 1998 and the total requested was \$61,653. The village board has committed to offsetting the water rate increase through, at minimum, a reduction in the sewer rates. After the loan for the sewer treatment plant was paid, we have been focused on the many maintenance projects that had been deferred because of lack of funds. It has taken the board many years to rebound from the decades-old operating deficits in our water and sewer utilities and we feel strongly about the track we are on for a more secure financial future.

Centerville Creek Restoration and Hika Park Enhancement Nearing Completion

Folks living near Hika Park and Centerville Creek in Cleveland have witnessed many enhancements these last seven years thanks to a five-phase restoration project undertaken by the Lakeshore Natural Resource Partnership and Friends of Hika Bay, and now in its final stage.

This project started in 2009. A local Citizen Advisory Committee formed to fully assess the abandoned millpond area and Hika Park, eventually becoming the Friends of Hika Bay and helping guide the Centerville Creek restoration.

In Phase I, UW-Madison landscape architecture students created designs for Hika Park. UW-Manitowoc biological science students of Drs. Rebecca Abler and Richard Hein began monitoring five creeks in southern Manitowoc County to assess water quality conditions and trends.

This partnership earned the Hika Bay group and LNRP the 2012 Wisconsin Idea Award from UW Colleges and UW-Extension for successively "bringing together the community and the university in the common goal of improving and protecting the water quality in northeastern Wisconsin...providing students with a life-enhancing opportunity to get boots-on-the-ground, in-the-field experience in the biological sciences."

Phase II, Centerville Creek restoration, included stream remeandering, invasive species removal, and restoration planting, and included holding public meetings, completing a land survey, engineering designs by Interfluve, and all permitting. Phase III entailed addressing administrative details, which led the Village Board to approve expanding Hika Park from 2.2 to 13.9 acres, and forming an 'adopt-a-park' initiative with the local group. Phase IV focused on invasive species trainings and removal, beach cleanups, and additional Hika Shores restoration plantings.



Phase V will complete the pedestrian bridge, connecting the area near the boat landing with the Hika Shores property to the north, and add two interpretive kiosks. One near Hika Shores on the bridge's north side will inform visitors about Lake Michigan shoreline habitats. The second along Centerville Creek near the viewing platform will feature historical photos and the creek restoration. Stay tuned for a grand opening next spring!

There should be a smoke detector in every bedroom, outside each sleeping area and on every level of the home, including the basement. Carbon monoxide is a colorless and odorless gas, so there should be a carbon monoxide detector placed on every floor. If you suspect carbon monoxide in your home, call 911 immediately.


FUTURES SCHOLARSHIPS

UTILITY RATES AND LATE FEE CHANGES

Effective after the December 2017 meter readings, the rules and rates for the water and sewer utilities will be changing. The Village Board has directed that sewer utility rates will decrease to offset a State-required increase in the water utility rates. The impact to most residential bills is designed to be neutral.

The water and sewer utilities are separate entities that share one bill. The Public Service Commission of Wisconsin (PSC) regulates the water utility only, and must approve all changes to operating rules and rates. The sewer utility rules and rates are set by the Village Board, subject to general statutory and administrative code provisions.

This year, the water utility filed its first conventional rate case application since 1998, which was approved by the PSC in November 2017. The approval provides a rate adjustment but also a much-needed update to the water utility's operating rules. One of these rules is the late charge policy.

Late charge policy On average, 15% of the Village's utility accounts are delinquent each month. Under the new policy, the late fee will be 1% of the past due balance, rather than the current policy of a one-time 3% charge. This will reduce the cost to the normally-timely customer with the odd missed payment but increase the fee for those who carry longer-term arrearages or who miss a payment under a payment agreement.

<u>Rates</u> The Village Board has directed staff to present reduced sewer utility rates that will offset the water utility rate change for a majority of customers. We are proposing adjustments to both fixed and volume charges, with a focus on residential customers. The effect on an individual bill will depend upon the meter size and classification, and gallons of usage at that property. These proposed rates will be presented to the Village Board at its December 19, 2017, meeting. Updated rate information will be posted to the Village website afterward.

The next newsletter will include an article on deferred sewer utility maintenance and the impact on rates.
