ZONING ORDINANCE AMENDMENT JASON BERDYCK and VILLAGE OF CLEVELAND

WHEREAS, Jason Berdyck filed a certified survey map ("the Berdyck CSM") to acquire approximately 111.47' of land from the parcel located at 1039 N. Linden St., owned by the Village of Cleveland; and

WHEREAS, the Plan Commission, at the request of the property owner and after public testimony, recommended that the zoning of Lot 1 and Lot 2 of the Berdyck CSM be changed to MS-1 *Main Street District*; and

WHEREAS, the Village Board has considered the zoning request on Tuesday, June 16, 2020, after a properly noticed public hearing and consideration of the Plan Commission's recommendation; and

WHEREAS, the proposed zoning changes are consistent with the Village of Cleveland 20-Year Comprehensive Plan and the Official Map;

NOW, THEREFORE, the Village Board of the Village of Cleveland, pursuant to Sec. 62.23, Wis. Stats., do ordain as follows:
